WHEREAS, Pandora Media, INC. has submitted supporting documentation to the Department of Finance Office of Revenue to make necessary adjustments to the business licensing system; and

WHEREAS, the Office of Revenue investigated the claim and has determined that, Pandora Media, INC is entitled to a refund in the amount of \$36,920.00.
