

AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE WAIVING THE COMPETITIVE SOURCE SELECTION REQUIREMENTS CONTAINED IN SECTION 2-1187 ARTICLE X PROCURMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA CODE OF ORDINANCES AND AUTHORIZING JACKMONT HOSPITALITY, INC. AND GLOBAL CONCESSIONS, INC. (JV), TO PROVIDE, AND THE CITY OF ATLANTA TO ACCEPT, RESTAURANT AND BAR CONCESSIONS ON CONCOURSE E AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT UNDER THE TERMS SET FORTH IN AGREEMENT FC-6004007847, AS AMENDED, COMMENCING ON AUGUST 29, 2016 AND CONTINUING MONTH-TO-MONTH, FOR A PERIOD NOT TO EXCEED SIX (6) MONTHS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City"), as owner and operator of Hartsfield-Jackson Atlanta International Airport (the "Airport") entered into Agreement FC-6004007847 with Jackmont Hospitality, Inc. and Global Concessions, Inc. (JV), on May 31, 2006 to manage three (3) restaurant and bar locations on Concourse E at the Airport (the "Agreement"), pursuant to Resolution 05-R-1837 adopted by the Atlanta City Council on October 17, 2005 and approved as per City Charter Section 2-403 on October 26, 2005; and

WHEREAS, the Agreement was amended on January 30, 2008 to add one (1) additional space to this Food and Beverage Lease for a total of four (4) food and beverage locations on Concourse E; and

WHEREAS, the Agreement, as previously amended, expires on August 28, 2016; and

WHEREAS, the Department of Aviation is in the process of soliciting for Food and Beverage Concessions on Concourse E; and

WHEREAS, it is in the City's best interest to provide for continuation of Food and Beverage Concessions on Concourse E while the solicitation is completed; and

WHEREAS, the Aviation General Manager and Chief Procurement Officer have recommended that Jackmont Hospitality, Inc. and Global Concessions, Inc. (JV) be authorized to continue providing Food and Beverage Concessions on Concourse E, uninterrupted, and that the City be authorized to accept such concessions under the terms set forth in the Agreement, as amended, on a month-to-month basis for a period not to exceed six (6) months commencing on August 29, 2016.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:

SECTION1: Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta Code of Ordinances is waived to the extent of any conflict with this ordinance.

SECTION2: That Jackmont Hospitality, Inc. and Global Concessions, Inc. (JV) are authorized to provide food and beverage concessions on Concourse E, and the City is authorized to accept such concessions, under the terms set forth in the Agreement, as amended, commencing on August 29, 2016 and continuing month-to-month, for a period not to exceed six (6) months.

SECTION 3: That all ordinances or parts of ordinances in conflict with this ordinance, including but not limited to Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta Code of Ordinances are hereby waived to the extent of the conflict only.
