

AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE WAIVING THE COMPETITIVE SOURCE SELECTION REQUIREMENTS CONTAINED IN SECTION 2-1187 ARTICLE X PROCUREMENT AND REAL ESTATE CODE OF THE CITY OF ATLANTA CODE OF ORDINANCES AND AUTHORIZING GOODRUM ENTERPRISES, INC., (D/B/A MCDONALD'S) TO PROVIDE, AND THE CITY OF ATLANTA TO ACCEPT, CONCOURSE E NATIONAL AND REGIONAL BRANDED HAMBURGER CONCESSIONS AT HARTSFIELD-JACKSON ATLANTA INTERNATIONAL AIRPORT UNDER THE TERMS SET FORTH IN AGREEMENT FC-6004007848, AS AMENDED, COMMENCING ON JUNE 4, 2016 AND CONTINUING MONTH-TO-MONTH, FOR A PERIOD NOT TO EXCEED SIX (6) MONTHS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (the "City"), as owner and operator of Hartsfield- Jackson Atlanta International Airport (the "Airport") entered into Agreement FC-6004007848 with Goodrum Enterprises, Inc., (d/b/a McDonald's) on March 22, 2006 to manage one national or regional Branded Hamburger Concessions located on Concourse E at the Airport (the "Agreement"), pursuant to Resolution 05-R-1839 adopted by the Atlanta City Council on October 17, 2005 and approved by the Mayor on October 25, 2005; and

WHEREAS, the Agreement, as previously amended, expires on June 3, 2016; and

WHEREAS, the Department of Aviation is in the process of soliciting for food and beverage concessions on Concourse E: and

WHEREAS, it is in the City's best interest to provide for continuation of food and beverage concessions on Concourse E while the solicitation is completed; and

WHEREAS, the Aviation General Manager and Chief Procurement Officer have recommended that Goodrum Enterprises, Inc., (d/b/a McDonald's) be authorized to continue providing food and beverage concessions on Concourse E, uninterrupted, and that the City be authorized to accept such concessions under the terms of the Agreement on a month-to-month basis for a period not to exceed six (6) months commencing on June 4, 2016.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS:

SECTION 1: Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta Code of Ordinances is waived to the extent of any conflict with this ordinance.

SECTION2: That Goodrum Enterprises, Inc., (d/b/a McDonald's) is authorized to provide food and beverage concessions on Concourse E, and that the City is authorized to accept such concessions, under the terms set forth in the Agreement, commencing on June 4, 2016 and continuing month-to-month, for a period not to exceed six (6) months.

SECTION 3: That all ordinances or parts of ordinances in conflict with this ordinance, including but not limited to Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta Code of Ordinances are hereby waived to the extent of the conflict only.
