

**A RESOLUTION BY COUNCILMEMBER JOYCE M. SHEPERD AMENDING 14-R-3502, WHICH AUTHORIZED THE CREATION OF THE AIRPORT WEST COMMUNITY IMPROVEMENT DISTRICT AS AUTHORIZED BY THE GENERAL ASSEMBLY OF THE STATE OF GEORGIA IN THE FULTON COUNTY COMMUNITY IMPROVEMENT DISTRICT ACT DISTRICT, FOR THE PURPOSE OF EXPANDING THE BOUNDARIES OF THE COMMUNITY IMPROVEMENT DISTRICT; AND FOR OTHER PURPOSES.**

WHEREAS, by Act of the Georgia General Assembly, Ga. L. 1987, p. 5460, the Fulton County Community Improvement Districts Act (the "Act") was enacted; and

WHEREAS, Resolution 14-R-3502, adopted by the Atlanta City Council on May 5, 2014, and approved as per City Charter Section 2-403 on May 14, 2014 authorized the creation of the Airport West Community Improvement District; and

WHEREAS, a majority of the owners of real property within a proposed expansion area of the Airport West Community Improvement District ("CID"), as shown on the map attached hereto as Exhibit "A" and list of tax parcels attached hereto as Exhibit "B", and incorporated herein by referenced, which real property will be subject to taxes, fees, and assessments levied by the District Board, have consented in writing to be included in the Airport West CID with boundaries as shown on the above-referenced map; and

WHEREAS, the owners of real property within the proposed expansion of the CID which constitutes at least 75% by value of all real property within said CID which shall be subject to taxes, fees and assessments by the District Board, according to the most recent approved Fulton County ad valorem tax digest, have consented in writing to be included in the Airport West CID, with expanded boundaries as shown on the above-referenced map and list; and

WHEREAS, the aforesaid written consents have been certified as satisfactory in compliance with the Act to be included within the boundaries of the Airport West CID as attached hereto as Exhibit "C"; and

WHEREAS, the City has determined the expansion of the Airport West CID would help provide additional governmental services and facilities within said district; and

NOW, THEREFORE, BE IT RESOLVED, that the City of Atlanta, Georgia consents to the expansion of the Airport West Community Improvement District and to be comprised of the expanded geographical area as shown on the map and list attached hereto as Exhibit "A" and respectively, for the provisions as provided for of the following governmental services and facilities:
