

AN ORDINANCE BY COUNCILMEMBER JOYCE SHEPERD AS SUBSTITUTED BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE AUTHORIZING THE MAYOR OR HIS DESIGNEE, ON BEHALF OF THE ATLANTA WORKFORCE DEVELOPMENT AGENCY, TO ACCEPT A YOUTHBUILD PROGRAM GRANT IN THE AMOUNT OF ONE MILLION ONE HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$1,100,000.00) FROM THE U.S. DEPARTMENT OF LABOR; AND DIRECTING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY2017 (JOB TRAINING GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF ONE MILLION ONE HUNDRED THOUSAND DOLLARS AND ZERO CENTS (\$1,100,000.00); AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta has been awarded a U.S. Department of Labor YouthBuild Grant (Attachment A); and,

WHEREAS, the Atlanta Workforce Development Agency and its Board of Directors implement and administer said grant; and,

WHEREAS, YouthBuild program participants must be 16 to 24 years of age who have dropped out of school, or have dropped out and re-enrolled, and meet one or more of the following criteria: member of a low-income family; in - or aging out of - foster care; involved in the criminal justice system; disabled; parent(s) who is incarcerated; migrant worker, or member of a migrant worker family; and,

WHEREAS, activities funded by the YouthBuild Grant include, but are not limited to: GED test preparation, occupational skills training, employment services, leadership development, and community service projects; and,

WHEREAS, the grant has a period of performance that commenced on October 17, 2016 and concludes on February 16, 2020.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Mayor or his designee is authorized, on behalf of the Atlanta Workforce Development Agency, to accept a YouthBuild Grant from the U.S. Department of Labor in the amount of One Million One Hundred Thousand Dollars And Zero Cents (\$1,100,000.00).

SECTION 2: That the Chief Financial Officer is directed to amend the FY2017 (Job Training Grant Fund) Budget as follows:
