

**AN ORDINANCE BY COUNCILMEMBERS MARY NORWOOD, CLETA WINSLOW, C. T. MARTIN, MICHAEL JULIAN BOND, AND ANDRE DICKENS REQUESTING THE DEPARTMENT OF PUBLIC WORKS PURCHASE AND INSTALL NINE (9) TRASH RECEPTACLES FOR USE IN VARIOUS NEIGHBORHOODS IN SOUTHWEST ATLANTA; AND FOR OTHER PURPOSES.**

WHEREAS, littering and dumping, a problem City of Atlanta neighborhoods face, often results from the lack of commercial grade trash receptacles available to communities; and

WHEREAS, trash receptacles mitigate littering and dumping and contribute to the beautification of neighborhoods; and

WHEREAS, nine Atlanta neighborhoods, all located in the Southwest corridor, have requested a total of nine (9) commercial trash receptacles in areas identified as priority zones (depicted in Exhibit A); and

WHEREAS, these neighborhoods appealed to the Atlanta City Council for an increase in the Fiscal Year 2017 Budget for Code Enforcement initiatives, requesting 200 trash receptacles be installed throughout Southwest Atlanta, however this request was unmet; and

WHEREAS, due to the lack of access to capital, the residents have requested assistance from the Post 2 At-Large Councilmember; and

WHEREAS, to ensure the streets are free of debris and trash, which is vital to the creation of safe and vibrant communities, the Post 2 At-Large Councilmember is requesting the Department of Public Works purchase and install nine (9) commercial trash receptacles.

WHEREAS, the Department of Public Works will coordinate the purchase and installation of the commercial trash receptacles.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS, as follows:

SECTION 1: That the Department of Public Works will coordinate the purchase and installation of nine (9) trash receptacles with the Post 2 A-Large Councilmember's office.

SECTION 2: That these efforts will be completed within 90 days after the adoption of this ordinance.

SECTION 3: That the Department of Public Works will service these receptacles on a predetermined scheduled after installation.

SECTION 4: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby waived in this instance only.


