

**AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA, TO APPLY FOR AND ACCEPT A GRANT IN THE AMOUNT OF FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$50,000.00) FROM NATIONAL ENDOWMENT FOR THE ARTS IN SUPPORT OF THE FREEDOM PATHWAY PUBLIC ART PROJECT; AND AUTHORIZING THE MAYOR TO ENTER INTO ANY NECESSARY AGREEMENTS IN CONNECTION WITH THE GRANT; AND AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE 2017 (INTERGOVERNMENTAL GRANT FUND) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF UP TO FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$50,000.00) TO ACCOUNTS AS LISTED HEREIN; AND FOR OTHER PURPOSES.**

WHEREAS, the Office of Cultural Affairs promotes art and cultural experiences throughout the City of Atlanta (“City”); and

WHEREAS, the Office of Cultural Affairs has been awarded a grant from National Endowment for the Arts in the amount of Fifty Thousand Dollars and No Cents (\$50,000.00) to be used in support of the Freedom Pathway Public Art Project (the “Grant”); and

WHEREAS, the Grant requires a match to be provided by the Mayor’s Office of Cultural Affairs in the form of in-kind services; and

WHEREAS, the City's FY2017 (Intergovernmental Grant Fund) Budget must be amended to anticipate and appropriate the Fifty Thousand Dollars and No Cents (\$50,000) from National Endowment for the Arts; and

WHEREAS, it is desirable and in the best interest of the City to participate in the Grant.

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Mayor or his designee, on behalf of the City is hereby authorized to apply for, accept and enter into any necessary agreements in connection with the Grant.

SECTION 2: That any actions taken by the City in applying for, accepting or in connection with the Grant are hereby ratified.

SECTION 3: That any match required under the Grant shall be provided by the Mayor’s Office of Cultural Affairs in the form of in-kind services.

SECTION 4: That any agreement(s) entered into in connection with the Grant shall not become binding on the City and the City shall incur no liability upon same until such has been approved by the City Attorney as to form, executed by the Mayor or his designee, attested to by the Municipal Clerk and delivered to National Endowment for the Arts.

SECTION 5: That the FY2017 (Intergovernmental Grant Fund) Budget is hereby amended as follows:
