

**AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN RESOURCES COMMITTEE ADOPTING THE FIVE YEAR UPDATE TO THE VINE CITY/WASHINGTON PARK LIVABLE CENTERS INITIATIVE (LCI) AS REQUIRED BY THE ATLANTA REGIONAL COMMISSION (ARC); AUTHORIZING THE DEPARTMENT OF PLANNING AND COMMUNITY DEVELOPMENT, ON BEHALF OF THE CITY OF ATLANTA, TO SUBMIT TO THE ARC THE VINE CITY/WASHINGTON PARK FIVE YEAR UPDATE; AND FOR OTHER PURPOSES. (HELD 12/1/15) (HELD AT THE REQUEST OF THE DEPARTMENT FOR FURTHER REVIEW)**

WHEREAS, the Atlanta Regional Commission's (ARC) Livable Centers Initiative (LCI) program encourages local governments to create plans that link transportation improvements with land use development strategies to create mixed use communities consistent with regional development policies;

WHEREAS, the ARC previously awarded the City of Atlanta grant funds to conduct an LCI plan for the Vine City/Washington Park area;

WHEREAS, the Office of Planning previously completed the plan and the Atlanta City Council adopted it into the City's Comprehensive Development Plan pursuant to Resolution 09-O-0943;

WHEREAS, community members of the Washington Park neighborhood completed the Washington Park Neighborhood Visioning Plan and the Atlanta City Council adopted the plan into the City's Comprehensive Development Plan and incorporated the document into the Vine City/Washington Park LCI per Ordinance 15-O-1262; and

WHEREAS, the Atlanta Regional Commission (ARC) requires local governments to adopt, by resolution, a five year update that includes an Evaluation and Appraisal Report and an Implementation Plan with an updated five (5) year Action Plan to be submitted five years after the plan is approved by the ARC ("LCI Five Year Plan Update"); and

WHEREAS, the LCI Five Year Plan Update is now due to the ARC.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY RESOLVES to adopt the Vine City/Washington Park LCI Five Year Plan Update, attached hereto as Exhibit "A".

BE IT FINALLY RESOLVED that the Department of Planning and Community Development is authorized to submit Vine City/Washington Park LCI Five Year Plan Update report to the Atlanta Regional Commission.
