

AN ORDINANCE BY COUNCILMEMBER MICHAEL JULIAN BOND AS SUBSTITUTED BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE TRANSFER OF ONE THOUSAND EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$1,800.00) FROM THE POST 1 AT-LARGE CARRY FORWARD ACCOUNT TO THE POST 1 AT-LARGE DISTRIBUTION ACCOUNT TO MAKE CHARITABLE DONATIONS TO THE MOTHERLESS DAUGHTERS FOUNDATION, THE MORRIS BROWN COLLEGE FOUNDATION AND THE URBAN LEAGUE OF GREATER ATLANTA TO SERVE THE PUBLIC GOOD; AND FOR OTHER PURPOSES.

WHEREAS, Pursuant to Section 2-39(a) of the City of Atlanta Code of Ordinances, councilmembers are permitted to utilize funds from their respective Council Distribution Account, to fund projects for the public good within their district or to donate funds for charitable purposes; and

WHEREAS, the Post 1 At-Large Councilmember has supported and continues to support various community-based activities throughout the Atlanta community for the public good; and

WHEREAS, the Post 1 At-Large Councilmember desires to transfer funds from the Post 1 At-Large Carry Forward Account to the Post 1 At-Large Distribution Account to make charitable donations to the Motherless Daughters Foundation, the Morris Brown College Foundation, and the Urban League of Greater Atlanta to serve the public good.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY 2017 General Fund budget as follows:
