

**AN ORDINANCE BY COUNCILMEMBER MICHAEL JULIAN BOND AUTHORIZING A DONATION IN AN AMOUNT NOT TO EXCEED THREE HUNDRED DOLLARS AND ZERO CENTS (\$300.00) FROM THE POST 1 AT-LARGE CARRY FORWARD ACCOUNT TO THE UNITY NETWORK AND COUNSELING CENTER, INC.; AND FOR OTHER PURPOSES.(HELD 8/24/16 BY THE COMMITTEE FOR ADDITIONAL INFORMATION)**

WHEREAS, the Unity Network and Counseling Center, Inc. ("UNCC") is an organization of shared vision, resources and planning, across public and private boundaries, dedicated to improving the life conditions of those persons who are caught in a cycle of poverty, dependency, and persistent social and economic disability; and

WHEREAS, the mission of the UNCC is to create programs for the disadvantaged to acquire workplace skills and to provide opportunities for inner city youth to participate in sports, educational, cultural, and community enrichment programs; and

WHEREAS, the UNCC is committed to the development and self-actualization of individuals in need; and

WHEREAS, the UNCC is funded almost entirely by donations; and

WHEREAS, UNCC is not currently a registered nonprofit organization with the State of Georgia Secretary of State; and

WHEREAS, it is the desire of the Post 1 At-Large Councilmember to donate Three Hundred and Dollars and Zero Cents (\$300.00) to support the Unity Network and Counseling Center's 20th anniversary of community outreach that help inner-city youth.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, to be read as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit a payment of Three Hundred Dollars and Zero Cents (\$300.00) to the Unity Network and Counseling Center, Inc.

SECTION 2: That all payments shall be charged to and made from the following:
