

**A RESOLUTION BY COMMUNITY DEVELOPMENT/HUMAN SERVICES COMMITTEE AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY OF ATLANTA TO ENTER INTO A CONTRACT AMENDMENT TO THE CONTRACTUAL AGREEMENT WITH MAKING A WAY HOUSING, INC., FOR THE HOPWA PROJECT HP-2015-66, MAKING A WAY HOUSING HOPWA, IN THE AMOUNT OF EIGHT HUNDRED SEVENTY-TWO THOUSAND EIGHT HUNDRED TWENTY-FOUR DOLLARS (\$872,824.00) FOR SERVICES AND FOR ACQUISITION AND REHABILITATION OF EIGHT HOUSING UNITS FOR PERSONS WITH HIV/AIDS; SAID ACTIVITIES TO BE CHARGED AND PAID FROM PTAEOS: 04212137 4788 250132266 5239003 (\$427,524.00) AND 04212137 4789 250132266 5239003 (\$445,300.00); AND FOR OTHER PURPOSES.**

WHEREAS, the City of Atlanta (“City”) manages the Housing Opportunities for Persons With AIDS (“HOPWA”) program of the U.S. Department of Housing and Urban Development for the twenty-nine county Atlanta Eligible Metropolitan Area; and

WHEREAS, project HP-2015-66, Making A Way Housing HOPWA, is funded under the City’s HOPWA program through sub-recipient agreements with Making A Way Housing, Inc.; and

WHEREAS, project HP-2015-66 funds supportive transitional housing and services for homeless persons living with HIV/AIDS, including twenty transitional housing units; and

WHEREAS, project HP-2015-66 also funds the acquisition and rehabilitation of an additional eight units of supportive transitional housing for homeless persons living with HIV/AIDS; and

WHEREAS, the contract agreement for project HP-2015-66 has a term of July 1, 2015 through June 30, 2017; and

WHEREAS, this term is insufficient for completion of all the needed rehabilitation elements; and

WHEREAS, the Mayor’s Office of Human Services recommends entering into a contract amendment to the existing agreement with Making A Way Housing, Inc. for project HP-2015-66, to extend the contract term through June 30, 2018, with no change in funding or scope of work, in order to allow adequate time for completion of all rehabilitation work.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor or his designee be and is hereby authorized to enter into a contract amendment to the contractual agreement with Making A Way Housing, Inc. for HOPWA project HP-2015-66, Making A Way Housing HOPWA, in the amount of Eight Hundred Seventy-Two Thousand Eight Hundred Twenty-Four Dollars (\$872,824.00), to extend the contract term through June 30, 2018. Said services are to be charged to and paid from PTAEO 04212137 4788 250132266 5239003 (\$427,524.00) and 04212137 4789 250132266 5239003 (\$445,300.00).

BE IT FURTHER RESOLVED, that the City Attorney be and is hereby directed to prepare the appropriate contractual amendment for execution by the Mayor or his designee.

BE IT FURTHER RESOLVED, that said contractual amendment shall not become binding on the City and the City shall incur no liability upon same until such amendment is approved by the City Attorney as to form, executed by the Mayor or his designee, attested to by the Municipal Clerk, and delivered to Making A Way Housing, Inc.
