

AN ORDINANCE BY COMMUNITY DEVELOPMENT/HUMAN SERVICES COMMITTEE AMENDING THE FY2018-2019 BUDGET (INTERGOVERNMENTAL GRANT FUND) BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS THE AMOUNT OF ONE HUNDRED SIXTY-SIX THOUSAND THREE HUNDRED FIFTY-FIVE DOLLARS AND ZERO CENTS (\$166,355.00) INCREASING THE BUDGET AMOUNT AUTHORIZED BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE CITY OF ATLANTA’S SECTION 8 MODERATE REHABILITATION PROGRAM FOR THE WASHINGTON STREET APARTMENTS; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta’s (“City”) Section 8 Moderate Rehabilitation Program is a rental subsidy program that benefits low-income families and individuals; and

WHEREAS, the City administers a Housing Assistance Payment (“HAP”) contract to Washington Street Apartments, LLC for Washington Street Apartments which has been approved by U. S. Department of Housing and Urban Development (“HUD”) for sixteen (16) units through December 31, 2018 under the Section 8 Moderate Rehabilitation Program; and

WHEREAS, the budget authority awarded by HUD for this project is One Hundred Sixty-Six Thousand Three Hundred Fifty-Five 00/100 Dollars (\$166,355.00) which represents the rent subsidy to the property owner, Washington Street Properties, LLC. and administrative costs for the City; and

WHEREAS, the Department of City Planning, Office of Housing and Community Development recommends increasing estimated receipts in the 2018-2019 budget (Intergovernmental Grant Fund) by One Hundred Sixty-Six Thousand Three Hundred Fifty-Five 00/100 Dollars (\$166,355.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2018-2019 Budget (Intergovernmental Grant Fund), Department of City Planning, be and is hereby amended as follows:
