

AN ORDINANCE BY COUNCILMEMBER MICHAEL JULIAN BOND REQUESTING THE COMMISSIONER OF WATERSHED MANAGEMENT REVIEW AND MAKE THE NECESSARY BILLING ADJUSTMENTS TO THE WATER AND SEWER BILL OF MS. RUTH STARKS; AND FOR OTHER PURPOSES.▶(HELD 9/25/18 AT THE REQUEST OF THE DEPARTMENT FOR ADDITIONAL INFORMATION.)

WHEREAS, Ms. Ruth Starks is a 91-year old young lady residing at 732 Bernice Street, S.W.; and

WHEREAS, Ms. Starks water and sewer bill is in her deceased husband's name; and

WHEREAS, Ms. Starks received a \$27,000.00 water and sewer bill from the City of Atlanta, and has made numerous attempts to the Department of Watershed Balance rectify her outstanding balance to no avail; and

WHEREAS, the Commissioner of the Department of Watershed Management has the authority to make billing adjustments and credits to water and sewer bills, pursuant to Section 154-27 (b) of the City of Atlanta Code of Ordinances; and

WHEREAS, Ms. Starks is a senior citizen living on a fixed income without the means to pay a large utility bill; and

WHEREAS, the City Council hereby requests the Commissioner of the Department of Watershed Management to review the water and sewer bill of Ms. Ruth Starks, and provide credits and adjustments to her bill as necessary.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS *as follows*:

SECTION 1: That the Commissioner of the Department of Watershed Management is hereby requested to review the water and sewer bill of Ms. Ruth Starks, residing at 732 Bernice Street, S.W.

SECTION 2: that upon review of Ms. Starks water and sewer account, including determining any identified leaks, the Commissioner shall make all necessary credits and adjustments.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict only.
