

AN ORDINANCE BY COUNCILMEMBER J. P. MATZIGKEIT AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY2019 SOLID WASTE RENEWAL AND EXTENSION FUND (5402) BUDGET BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF ELEVEN MILLION, SIX HUNDRED SIXTY TWO THOUSAND SIXTY-SEVEN DOLLARS AND SEVENTY-FIVE CENTS (\$11,662,067.75) FOR THE PURCHASE OF EQUIPMENT AND VEHICLES; AND FOR OTHER PURPOSES.▶(HELD 1/15/19 AT THE REQUEST OF THE DEPARTMENT.)

WHEREAS, the City of Atlanta ("City") collects and disposes of municipal solid waste;

WHEREAS, the City authorized a Cooperative Purchasing Agreement Number COA-10031- WS with First Municipal Credit Company, LLC to provide financing utilizing a master purchasing agreement for the purchase of equipment and replacement vehicles ("Agreement") on behalf of various Departments of the City, pursuant to Resolution No. 17-R-4371;

WHEREAS, in support of the Department of Solid Waste Services, the City will acquire certain vehicles and heavy equipment required for the collection and disposal of solid waste utilizing the Agreement;

WHEREAS, pursuant to the terms of the Agreement, the City will establish an escrow account to be held by an escrow agent pending acquisition of the equipment and vehicles; and

WHEREAS, the FY 2019 Solid Waste Renewal and Extension Fund (5402) Budget should be amended by adding to Anticipations and Appropriations in the amount of Eleven Million, Six Hundred Sixty Two Thousand Sixty-Seven Dollars and Seventy Five Cents (\$11,662,067.75) to facilitate the use of the funds for the Solid Waste Services Vehicle & Heavy Equipment Replacement Program.

THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1: That the Chief Financial Officer is authorized to amend the FY 2019 Solid Waste Renewal and Extension Fund (5402) Budget as follows:
