SECTION 1. An ordinance to amend the Land Use element of the 2016 Atlanta Comprehensive Development Plan (CDP) so as to redesignate property located at 135 West Wieuca Road NE, 165 West Wieuca Road NE (AKA 141 West Wieuca Rd) and 173 West Wieuca Road NE, from The Low Density Commercial land use designation to the High Density Residential land use designation and 0 Wieuca Road NE (parcel ID 17 00950003118) from the Single Family Residential land use designation to the High Density Residential land use designation and for other purposes (Z-18-119) to wit:

All that tract or parcels of land lying and being in Land Lot 95 of the 17th district of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
