WHEREAS, since 1968, Frederick Douglass High School (“FDHS”) has served the communities of historic Collier Heights, Peyton Forest, Cascade Heights, Center Hill, and the city of Atlanta; and

WHEREAS, Frederick Douglass High School was established in 1968 to relieve overcrowding at nearby Harper, Turner, and West Fulton High School; and

WHEREAS, many notable Atlantans have attended the school, including Bernice King, Ricky Byrdsong, Sonny Emory, Major General Leslie C. Smith, as well as the current Mayor and the City Council Post 1 At-Large Councilmember; and

WHEREAS, FDHS is embarking on a celebration of its 50th Anniversary and historical markers represent a tool for public memorialization: and

WHEREAS, it is important to publicly memorialize the historical significance of FDHS; and

NOW, THEREFORE, THE COUNCIL OF THE CITY OF ATLANTA GEORGIA HEREBY RESOLVES, that the Mayor or her designee is hereby authorized to place an historic marker in the City of Atlanta right-of-way at the entrance of Frederick Douglass High School to commemorate the school's 50th Anniversary.

BE IT FINALLY RESOLVED, that all resolutions or parts of resolutions in conflict herewith are hereby waived to the extent of the conflict.
