WHEREAS, the City of Atlanta ("City") has found that African American, Female, Hispanic, and Asian American owned businesses have suffered the effects of racial and gender discrimination in both public and private markets, resulting in the disproportionate award of contract dollars to non minority or non-female businesses; and

WHEREAS, the mission of the City is to mitigate the effects of past and present discrimination against women and minority businesses; and

WHEREAS, it is the responsibility of the all organizations within the city to promote full and equal business opportunity for all persons doing business with the City; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, that the President and CEO of the Atlanta Development Authority d/b/a Invest Atlanta and the Chief Procurement Officer are hereby requested to complete a disparity study that will provide the framework for a Disadvantages Business Enterprise/Minority Business Enterprise

Program for all publicly financed Invest Atlanta projects.

BE IT FURTHER RESOLVED, that the Invest Atlanta CEO and the Chief Procurement Officer shall issue its report no later than the first meeting of the Finance/Executive Committee held in January 2019.
