

**AN ORDINANCE BY COUNCILMEMBERS J. P. MATZIGKEIT AND DUSTIN HILLIS AUTHORIZING THE MAYOR OR HER DESIGNEE, TO REDUCE THE POSTED SPEED LIMIT ON THE ENTIRE LENGTH OF MOORES MILL ROAD FROM THIRTY-FIVE (35) MILES PER HOUR TO THIRTY (30) MILES PER HOUR; AND FOR OTHER PURPOSES.(HELD 2/13/19 AT THE REQUEST OF THE DEPARTMENT)**

WHEREAS, Moores Mill is a heavily utilized road that runs through Districts 8 and 9 and is mainly bordered by single-family neighborhoods; and

WHEREAS, due to safety concerns over an increase in speeding, neighborhood associations, NPU C and individual residents of the area have been advocating for comprehensive ways to slow traffic on Moores Mill; and

WHEREAS, if the speed limit were reduced from 35 mph to 30 mph, and such reduction was approved by GA DOT for the use of radar detections devices, slower speeds could be enforced thereby increasing the safety of residents and drivers.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS as follows:

SECTION 1: That the Mayor, or his designee, is authorized to reduce the posted speed limit on the entirety of Moores Mill Road from thirty-five (35) miles per hour to thirty (30) miles per hour.

SECTION 2: That the signage reflecting the above speed limit reduction shall be updated by the Department of Public Works within thirty (30) days of the adoption of this Ordinance.

SECTION 3: That all ordinances and parts of ordinances in conflict with the terms of this Ordinance are hereby repealed only to the extent of the conflict.
