

**AN ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE CHIEF FINANCIAL OFFICER (CFO), ON BEHALF OF THE DEPARTMENT OF CITY PLANNING, TO PAY OUTSTANDING INVOICES TO ATLANTA DOWNTOWN IMPROVEMENT DISTRICT, INC., (ADID) FOR SERVICING THE GOVERNMENT DISTRICT GROUNDS, IN AN AMOUNT NOT TO EXCEED TWO HUNDRED THIRTY-NINE, THOUSAND EIGHT HUNDRED SIXTY-NINE DOLLARS AND ZERO CENTS (\$239,869.00). ALL OUTSTANDING INVOICES SHALL BE CHARGED TO AND PAID FROM THE ACCOUNTS LISTED HEREIN; AND FOR OTHER PURPOSES.**

WHEREAS, Article IX, Section VII of the 1983 Constitution of the State of Georgia authorizes municipalities to create community improvement districts and pursuant to the “Atlanta Community Improvement District Act”, enacted by the Georgia General Assembly as House Bill 544, 1991 Ga. Laws 3653, the City of Atlanta created the Atlanta Downtown Improvement District (ADID) pursuant to the constitutional and statutory authority cited herein (Resolution 95-R-1374, as supplemented by Resolution 02-R-0241); and

WHEREAS, City Council Resolution 95-R-1374 authorized the ADID to provide such services and facilities to enhance the maintenance and use of streets, sidewalks, parks, plazas, recreational areas and facilities, public transportation facilities, parking facilities, and similar areas by providing, fostering and promoting the perception and reality of a safe and clean environment; and

WHEREAS, City Council Ordinance 16-O-1147 appropriated One Million Five Hundred Thousand Dollars and Zero Cents (\$1,500,000.00) in funding for the Government District Beautification; and

WHEREAS, the ADID is authorized to contract the City pursuant to the constitutional and statutory authority above referenced; and

WHEREAS, pursuant to the requirements of the Atlanta Community Improvement District (CID) Act, the boundaries of the Government District were expanded on May 8, 2000, so that the geographic area of the Government District include additional areas; and

WHEREAS, during the work phase, the Department of City Planning discovered that the work was for areas outside of the boundaries in the Atlanta Downtown Improvement District Inc. (ADID) agreement; and

WHEREAS, the Commissioner of the Department of City Planning desires authorization to pay invoices for servicing the Government District grounds to Atlanta Downtown Improvement District, Inc. in an amount not to exceed Two Hundred Thirty-Nine Thousand Eight Hundred Sixty-Nine Dollars and Zero Cents (\$239,869.00).



THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: The Chief Financial Officer (CFO) is authorized to appropriate funds to pay outstanding invoices for ground services for the Government District Beautification to Atlanta Downtown District, Inc., in an amount not to exceed Two Hundred Thirty-Nine Thousand Eight Hundred Sixty-Nine Dollars and Zero Cents (\$239,869.00).

SECTION 2: Section 2-1187 of Article X of the Procurement and Real Estate Code of the City of Atlanta Code of Ordinances is waived to the extent of any conflict with this Ordinance.

BE IT FURTHER RESOLVED, that all outstanding invoices shall be charged to and paid from:
