

A RESOLUTION BY COUNCILMEMBERS JOYCE M. SHEPERD AND DUSTIN HILLIS TO EXTEND THE CODE ENFORCEMENT COMMISSION UNTIL JUNE 30, 2021; AND FOR OTHER PURPOSES.

WHEREAS, the Code Enforcement Commission was established via Resolution 14-R-3671 adopted by the Atlanta City Council on June 16, 2014 and the same was approved as per City Charter Section 2-403 on June 24, 2014; and

WHEREAS, the Code Enforcement Commission was established for the purpose of restoring quality of life within the City of Atlanta by determining best practices to combat habitual violators of the Atlanta Housing Code for both commercial and residential properties; and

WHEREAS, the Code Enforcement Commission was initially established for a period of 12 months and was extended three times, most recently pursuant to Resolution 18-R-3148, adopted by the Atlanta City Council on February 19, 2018 and the same was approved as per City Charter Section 2-403 on February 28, 2018, until the end of Fiscal Year 2019, and

WHEREAS, the Code Enforcement Commission still has work to do extending into the future for a period of twenty-four (24) months.

NOW, THEREFORE, BE IT RESOLVED, that the Code Enforcement Commission is extended for a period of twenty-four (24) months, effective retroactively from July 01, 2019 through June 30, 2021.

BE IT FINALLY RESOLVED, that all resolutions and parts of resolutions, in conflict herewith are waived to the extent of the conflict.
