

******AN ORDINANCE BY COUNCILMEMBERS MICHAEL JULIAN BOND AND ANDRE DICKENS REQUESTING THE CITY OF ATLANTA'S LAW DEPARTMENT TO WITHDRAW ALL CONDEMNATION ACTIONS BY THE CITY OF ATLANTA AGAINST MS. TANYA WASHINGTON, MR. AND MRS. ROBERT DARDEN, AND MR. DWAYNE ADGAR; AND FOR OTHER PURPOSES.(THIS LEGISLATION IS A DUAL REFERRED ITEM AND WILL BE FORWARDED TO FINANCE/EXECUTIVE COMMITTEE PENDING A CITY UTILITIES COMMITTEE RECOMMENDATION)**

WHEREAS, Ms. Tanya Washington, Mr. & Mrs. Darden, and Mr. Dwayne Adgar (the "Parties") are residents of the Peoplestown neighborhood in the City of Atlanta; and

WHEREAS, persistent flooding in their neighborhood caused the City in 2017 to pursue eminent domain of her property to prevent storm water flooding issues; and

WHEREAS, it is in the best interest of the City to withdraw all condemnation actions against the Parties and to enter into any settlement negotiations.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the City of Atlanta Law Department withdraw all condemnation actions by the City of Atlanta against Ms. Tanya Washington, Mr. and Mrs. Robert Darden, and Mr. Dwayne Adgar.

SECTION 2: That the City Law Department enter into any necessary settlement negotiations with all parties

SECTION 3: All other Ordinances in conflict with this Ordinance are hereby waived to the extent of such conflict.
