

**AN ORDINANCE BY COUNCILMEMBER CLETA WINSLOW AUTHORIZING THE MAYOR OR HER DESIGNEE TO MAKE THE INTERSECTION OF LAWSHE STREET, S.W. AND PARSONS STREET, S.W. AN ALL-WAY STOP CONTROLLED INTERSECTION; TO AUTHORIZE THE DEPARTMENT OF PUBLIC WORKS TO INSTALL STOP SIGNS AT THE INTERSECTION; AND FOR OTHER PURPOSES.**

WHEREAS, the intersection of Lawshe Street, S.W. and Parsons Street, S.W. is located within the Clark Atlanta University complex and is traversed by several thousand students (both vehicular and pedestrians) each day; and

WHEREAS, this intersection is often congested, traversed by several thousand students, visitors and vehicles each day; and

WHEREAS, the installation of an all-way stop at this location will provide a safer crossing for pedestrians, meet the needs of the community and address traffic safety concerns.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the intersection of Lawshe Street, S.W. and Parsons Street, S.W. be made an all-way stop controlled intersection.

SECTION 2: That the Department of Public Works is authorized to install stop signs on all approaches of the intersection of Lawshe Street, S.W. and Parsons Street, S.W.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith be and the same are hereby repealed.
