

AN ORDINANCE BY COUNCILMEMBER CLETA WINSLOW AUTHORIZING A DONATION, IN AN AMOUNT NOT TO EXCEED THREE THOUSAND DOLLARS AND ZERO CENTS (\$3,000.00), FROM THE DISTRICT 4 CARRY FORWARD ACCOUNT TO ATLANTA POLICE FOUNDATION (CRIME STOPPERS OF GREATER ATLANTA) TO ASSIST IN FINDING THE SUSPECT FROM THE AUGUST 20 SHOOTING AT ATLANTA UNIVERSITY CENTER; AND FOR OTHER PURPOSES.

WHEREAS, the mission of Atlanta Police Foundation is to make Atlanta the safest and most inviting city for all residents, workers and visitors; and

WHEREAS, on August 20, 2019, four students were shot or grazed during an incident that occurred in the area of the Atlanta University Center Robert W. Woodruff Library; and

WHEREAS, it is the desire of the District 4 Councilmember to donate Three Thousand Dollars and Zero Cents (\$3,000.00) to Atlanta Police Foundation (Georgia Crime Stoppers of Greater Atlanta) to assist in finding the suspect from the August 20 shooting at Atlanta University Center; and

WHEREAS, this donation will bring the total reward to Five Thousand Dollars and Zero Cents (\$5,000.00) for providing pertinent information toward identifying the shooter.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed Three Thousand Dollars and Zero Cents (\$3,000.00) to Atlanta Police Foundation (Georgia Crime Stoppers of Greater Atlanta) to assist in finding the suspect from the August 20 shooting at Atlanta University Center.

SECTION 2: That all payments shall be charged to and made from the following account: 1001 (General Fund) 030204 (CCN Council District 4) 5790001 (Contingency Fund - Unrestricted) 1110000 (Governing Body) Councilmember Clela Winslow.

SECTION 3: That all ordinances and parts of ordinances in conflict herewith are hereby repealed for purposes of this ordinance only and only to the extent of the conflict.
