

**AN ORDINANCE BY COUNCILMEMBER CLETA WINSLOW AUTHORIZING A DONATION, IN AN AMOUNT NOT TO EXCEED FIVE THOUSAND TWO HUNDRED FIFTY DOLLARS AND ZERO CENTS (\$5,250.00), FROM THE DISTRICT 4 CARRY FORWARD ACCOUNT TO ASSIST VARIOUS COMMUNITY ORGANIZATIONS IN COUNCIL DISTRICT 4 WITH NEIGHBORHOOD EVENTS; AND FOR OTHER PURPOSES.**

WHEREAS, the Department of City Planning and the Atlanta BeltLine, Inc. have teamed up to coordinate two planning efforts; and

WHEREAS, collectively, these plans will reflect the community's vision and today's market conditions, while incorporating an action-oriented implementation plan; and

WHEREAS, the Fall meeting will be hosted at Shiloh Missionary Baptist Church; and

WHEREAS, it is the desire of the District 4 Councilmember to donate Five Hundred Dollars and Zero Cents (\$500.00) to Shiloh Missionary Baptist Church to assist with the West End LCI & Atlanta BeltLine Subarea Plan Meeting they will host; and

WHEREAS, the Castleberry Hill Neighborhood Association (CHNA) is in place to promote the health, safety and welfare of Castleberry Hill; and

WHEREAS, this is done through the preservation, restoration and rejuvenation of the Castleberry Hill neighborhood, the improvement of the quality of life for all residents who live therein, and the provision of a means of bringing the residents together to foster the discussion and resolution of community problems and interests as well as other programs and proposals; and

WHEREAS, it is the desire of the District 4 Councilmember to donate Two Hundred Fifty Dollars and Zero Cents (\$250.00) to Castleberry Hill Neighborhood Association, Inc. to support their 2019 Loft Tour; and

WHEREAS, one of the oldest neighborhoods in Atlanta, Mechanicsville sits in the shadow of both downtown Atlanta and Turner Field; and

WHEREAS, the Mechanicsville Civic Association, Inc. works closely with SUMMECH Community Development Corporation to develop and implement strategies for revitalization of the neighborhood; and

WHEREAS, it is the desire of the District 4 Councilmember to donate Five Hundred Dollars and Zero Cents (\$500.00) to Mechanicsville Civic Association, Inc. to support their community initiatives; and

WHEREAS, the West End Neighborhood Development, Inc. (WEND) was established in 1974 with the goal of improving the socioeconomic position of their community and its residents; and

WHEREAS, in order to increase awareness of the West End neighborhood, WEND has sponsored a tour of homes, a yearly festival Howell Park, and a driving tour booklet highlighting homes and cultural and religious centers; and

WHEREAS, WEND will hosts their 11<sup>th</sup> Annual Candlelight Concert on September 21, 2019 at The Wren's Nest; and

WHEREAS, it is the desire of the District 4 Councilmember to donate One Thousand Dollars and Zero Cents (\$1,000.00) to West End Neighborhood Development, Inc. to support their 11<sup>th</sup> Annual Candlelight Concert; and

WHEREAS, formed in 1988 with the consolidation of Clark College and Atlanta University, Clark Atlanta University is private, coeducational, historically black university in Atlanta, Georgia; and

WHEREAS, it is the desire of the District 4 Councilmember to donate One Thousand Dollars and Zero Cents (\$1,000.00) to Clark Atlanta University to support their community efforts; and

WHEREAS, it is the desire of the District 4 Councilmember to donate Two Thousand Dollars and Zero Cents (\$2,000.00) to Clark Atlanta University's Whitney M. Young, Jr. School of Social Work to support its 100<sup>th</sup> anniversary; and

WHEREAS, the District 4 Councilmember desires to donate an amount not to exceed Fifty Thousand Two Hundred Fifty Dollars (\$5,250.00) from the District 4 Carry Forward Account to various neighborhood associations within Council District 4, to assist the organizations with various neighborhood events.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed Five Hundred Dollars and Zero Cents (\$500.00) to Shiloh Missionary Baptist Church to assist with the West End LCI & Atlanta BeltLine Subarea Plan Meeting they will host.

SECTION 2: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed Two Hundred Fifty Dollars and Zero Cents (\$250.00) to Castleberry Hill Neighborhood Association, Inc. to assist with their 2019 Loft Tour.

SECTION 3: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed Five Hundred Dollars and Zero Cents (\$500.00) to Mechanicsville Civic Association, Inc. to support their community initiatives.

SECTION 4: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed One Thousand Dollars and Zero Cents (\$1,000.00) to West End Neighborhood Development, Inc. to support their 11<sup>th</sup> Annual Candlelight Concert.

SECTION 5: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed One Thousand Dollars and Zero Cents (\$1,000.00) to Clark Atlanta University to support their community initiatives.

SECTION 6: That the Chief Financial Officer is authorized to amend the FY 2020 General Fund Budget to remit a donation in an amount not to exceed Two Thousand Dollars and Zero Cents (\$2,000.00) to Clark Atlanta University's Whitney M. Young, Jr. School of Social Work to support their 100<sup>th</sup> anniversary.

SECTION 7: That all payments shall be charged to and made from the following account: 1001 (General Fund) 030204 (CCN Council District 4) 5790001 (Contingency Fund - Unrestricted) 1110000 (Governing Body) Councilmember Clea Winslow.

SECTION 8: That all ordinances and parts of ordinances in conflict herewith are hereby repealed for purposes of this ordinance only and only to the extent of the conflict.
