

**A RESOLUTION BY COMMITTEE ON COUNCIL APPOINTING MS. KRISTEN J. HALLORAN AS THE ATLANTA CITY COUNCIL APPOINTEE TO THE ATLANTA BELTLINE DESIGN REVIEW COMMITTEE IN THE BELTLINE TAX ALLOCATION DISTRICT ADVISORY COMMITTEE SEAT FOR A TERM OF TWO YEARS; AND FOR OTHER PURPOSES.  
(FAVORABLE BY ZONING COMMITTEE 9/11/19))**

WHEREAS, the Atlanta Beltline Design Review Committee was created pursuant to 14-R-4377 (Exhibit A), adopted by the Atlanta City Council on March 2, 2015 and approved as per City Charter Section 2-403, as an advisory group to review special administrative permit applications submitted to the City of Atlanta on projects within the Beltline Overlay District and provide recommendations to the Director of the Office of Planning on such applications; and

WHEREAS, the Committee is comprised of eight members, four of whom shall be by virtue of their title: the Atlanta Beltline, Inc. (ABI) Director of Design, ABI Program Manager, ABI Director of Community Planning and Engagement, Director of the City of Atlanta Office of Planning; three members of the public (two of whom shall be architects licensed in the state of Georgia and one of whom is an urban planning); and a member of the Beltline Tax Allocation District Advisory Committee, or their designee, who has experience or expertise in design; and

WHEREAS, the ABI President shall provide a list of committee member nominations to the City Council and the Council shall appoint from the listed of nominated members for a maximum of two consecutive two-year terms or until a qualified successor is appointed; and

WHEREAS, on August 8, the ABI President submitted the names of Mr. Stephen Causby and Ms. Kristen J. Halloran as nominations to the Committee (Exhibit B); and

WHEREAS, Ms. Kristen J. Halloran (bio attached) meets the requirements to serve in the Beltline Tax Allocation District Advisory Committee seat on the Atlanta Beltline Design Review Committee; and

WHEREAS, on August 14, 2019, the Chair of the Committee on Council sent a memo to all members of Council notifying them of a vacancy on the Atlanta Beltline Design Review Committee to be filled by appointment of the City Council (Exhibit C); and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that Ms. Kristen J. Halloran be appointed to the Atlanta Beltline Design Review Committee for a term two years.

BE IT FINALLY RESOLVED, that all resolutions and parts of resolutions, in conflict herewith are hereby waived to the extent of the conflict.
