BOONE AS SUBSTITUTED BY COMMUNITY DEVELOPMENT/HUMAN SERVICES COMMITTEE AUTHORIZING THE MAYOR ON BEHALF OF THE ATLANTA WORKFORCE DEVELOPMENT AGENCY, (A/K/A WORKSOURCE ATLANTA), TO AMEND FC-9895 (“ONE-STOP CAREER CENTER OPERATOR”) WITH IN THE DOOR, LLC TO EXPAND THE SCOPE OF WORK AND INCLUDE “NAVIGATOR,” “STAFF ACCOUNTANT” AND “ACCOUNTING SPECIALIST” POSITIONS; AND FOR OTHER PURPOSES.

WHEREAS, in July 2014 Congress adopted and President Barack Obama signed into law the Workforce Innovation and Opportunity Act (?WIOA? or the ?Act?); and

WHEREAS, the Act provides a framework for a workforce training and employment system designed to meet the needs of businesses, job seekers, and those wanting to further their careers; and

WHEREAS, the WIOA workforce delivery system is based on a One-Stop Career Center model, where access to a wide array of job training, education, and employment services is available for customers at a single location; and

WHEREAS, the Act authorizing Local Workforce Development Boards (?LWDB?) to develop and oversee the local One-Stop delivery system for the provisions of federal workforce development programs; and

WHEREAS, section 2 C.F.R. ? 683.220 (Exhibit A) requires sub-recipients of WIOA grant funds to establish an internal control structure to provide safeguards to protect grant funds, equipment and other sensitive information; and

WHEREAS, the contract will be amended to add a ?Navigator,? ?Staff Assistant,? and ?Accounting Specialist? positions (Exhibit B) and expand In The Door?s scope of work to include navigation services as directed by the Technical College System of Georgia, Office of Workforce Development.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Mayor, on behalf of the Atlanta Workforce Development Agency, also known as WorkSource Atlanta, is hereby authorized to execute an Amendment of the Renewal Agreement with In The Door, LLC for FC-9895 (?One-Stop Career center Operator?) in an amount not to exceed \$251,262.00 and authorize the establishment of a ?Navigator,? ?Staff Accountant,? and ?Accounting Specialist.?

BE IT FURTHER RESOLVED, that the contract will be amended to expand the Scope of Work to include navigator functions as directed by the Technical College System of Georgia, Office of Workforce Development.

BE IT FURTHER RESOLVED, that all contracted work shall be charged to and paid from:
