THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1. An ordinance to amend the Land Use element of the 2016 Atlanta Comprehensive Development Plan (CDP) so as to redesignate a portion of the property located at 1576 Donald Lee Hollowell Parkway from them Low Density Commercial (LDC) Land Use Designation to the Mixed Use-Medium Density (MUMD) Land Use Designation and for other purposes (Z-20-005) to wit:

All that tract or parcels of land lying and being in Land Lot 146 of the 14th district of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit ‘A’, which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
