SECTION 1. An ordinance to amend the Land Use Element of the 2016 Atlanta Comprehensive Development Plan (CDP) so as to redesignate property located at 1593 and 1595 Chattahoochee Avenue NW from the Industrial (I) Land Use to the Mixed Use Medium Density (MU-MD) Land Use Designation and for other purposes (Z-20-033) to wit:

All that tract or parcels of land lying and being in Land Lots 221 and 222 of the 17<sup>th</sup> district of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
