Please find attached a letter from The Atlanta Business League nominating Mr. Harold Hardnett, CEO of Hardnett Enterprises, Inc. to serve on the Atlanta Citizen Review Board (ACRB).

A background investigation was completed on Mr. Hardnett by Laborchex Inc., a registered city vendor. Attached to this letter is a copy of his investigation results based on the information provided to the ACRB by the Business League and Mr. Hardnett. The areas screened in the investigation included criminal records check (Georgia and Multi-State); driving record check (Georgia); previous employment and education. Mr. Hardnett's background appears to not have included a career in law enforcement; therefore, no police related professional affiliations were screened.

The investigation, completed by Laborchex, highlights no red alerts in the aforementioned areas. Therefore, based on the recommendation of the Atlanta Business League, coupled with the

Laborchex background, the ACRB moves this nomination forward for consideration and approval.
