

**AN ORDINANCE BY COUNCILMEMBER NATALYN ARCHIBONG AS SUBSTITUTED BY CITY UTILITIES COMMITTEE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO RENAME THAT PORTION OF BELL AVENUE, S.E. LOCATED BETWEEN GLENWOOD AVENUE, S.E. AND THE CORPORATE LIMITS OF THE CITY TO SUMMIT DRIVE, S.E.; TO WAIVE CERTAIN PROVISIONS OF THE CITY OF ATLANTA CODE OF ORDINANCES; AND FOR OTHER PURPOSES. (A PUBLIC HEARING WAS HELD ON 9/29/15)**

WHEREAS, Summit Drive, S.E., formerly known as Bell Avenue, S.E. is located from Glenwood Avenue, S.E. to the corporate limits of the City of Atlanta ("City"); and

WHEREAS, street identification signs, maps, and other official documents and markers recognize the street as Summit Drive, S.E., but no previous legislation exists of the renaming of this street from Bell Avenue, S.E. to Summit Drive, S.E.; and

WHEREAS, this legislation will address any concerns that may exist as to the official name of this street; and

WHEREAS, the Commissioner of the Department of Public Works has determined that the conditions outlined in Section 138-8 of the City of Atlanta Code of Ordinances for a street renaming or dedication have been fulfilled or are inapplicable to the current situation, and that the street renaming is in the best interests of the City.

WHEREAS, due to the fact that the street is already known by the name Summit Drive, S.E., and the purpose of this legislation is to formalize the same, the City Council recommends waiving certain provisions of the Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That Bell Avenue, S.E., located between Glenwood Avenue, S.E. and the corporate limits of the City be renamed to Summit Drive, S.E.

SECTION 2: That the requirement of Section 138-8(b)(4)(a) of the City of Atlanta Code of Ordinances, which requires *an initial \$2,500.00 deposit to cover administrative and other associated costs concerning the city's consideration of the application for the street renaming or dedication, including advertising the proposed street renaming or dedication, must also accompany the application* be waived for purposes of this ordinance only.

SECTION 3: That the requirements of Section 138-8 of application for street renaming, including the requirement to obtain signatures of 75 percent of the residents residing or businesses located on the street to which the street renaming applies, are hereby waived for purposes of this ordinance only.

SECTION 4: That the changes shall officially become effective upon the Mayor's approval.

SECTION 5: That all ordinances or parts of ordinances in conflict with the terms of this ordinance are hereby repealed, to the extent of the conflict.
