**AN AMENDED ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE AMENDING THE FY2016 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF THE EXECUTIVE OFFICES, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FIFTY THOUSAND DOLLARS AND ZERO CENTS (\$50,000.00) FROM NATURAL RESOURCES DEFENSE COUNCIL FOR THE IMPLEMENTATION OF THE AFFORDABLE MULTIFAMILY CITY CHALLENGE PILOT PROGRAM; ALL FUNDS TO BE DEPOSITED INTO ACCOUNTS AS LISTED BELOW; AND FOR OTHER PURPOSES.**

WHEREAS, Resolution 15-R-3414, adopted by the Atlanta City Council on April 20, 2015, and approved per City Charter Section 2-403 on April 29, 2015, authorized the Mayor or his designee, on behalf of the City of Atlanta (“City”), to apply for and accept a grant from the Natural Resources Defense Council to execute any required agreements for participation and implementation thereunder; and

WHEREAS, the City was awarded grant funds in the amount of Fifty Thousand Dollars and Zero Cents (\$50,000.00) to implement the Affordable Multifamily City Challenge Pilot Program (“Program”) in the City of Atlanta, a joint project of the Natural Resources Defense Council, Inc., and the Institute for Market Transformation and an innovative challenge for energy efficiency in affordable multifamily housing; and

WHEREAS, it is in the interest of the City to anticipate and appropriate the grant funds associated with the Program in the amount of Fifty Thousand Dollars and Zero Cents (\$50,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA hereby ordains as follows:

SECTION 1: That the FY 2016 (Intergovernmental Grant Fund) Budget, Department of Executive Offices, be and is hereby amended as follows:
