AN ORDINANCE BY COUNCILMEMBER C. T. MARTIN TO CORRECT ORDINANCE NUMBER 15-0-1486 ADOPTED BY THE ATLANTA CITY COUNCIL ON NOVEMBER 2, 2015 AND APPROVED ON NOVEMBER 11, 2015 WITHOUT SIGNATURE BY OPERATION OF LAW, TO CORRECT THE FUNCTION ACTIVITY FOR THE ATLANTA POLICE DEPARTMENT IN SECTION 2 "ANTICIPATIONS AND APPROPRIATIONS" TO REFLECT FUNCTION ACTIVITY 3223000 (PATROL); AND FOR OTHER PURPOSES.

WHEREAS, Ordinance Number 15-0-1486 (the "Legislation") was adopted by the Atlanta City Council on November 2, 2015 and approved by operation of law on November 11, 2015; and

WHEREAS, the Legislation appropriates and anticipates funding for payments under the 1998A Master Lease and Option ("Agreement") with the Georgia Municipal Association, Inc. ("GMA"), under which the City of Atlanta ("City") leases various items of equipment from GMA on behalf of various City departments after the City acquires the equipment on behalf of GMA, and GMA makes payment to the City for such acquisition; and

WHEREAS, in Section 2 of the Legislation, "Anticipation and Appropriation," the function activity for the Atlanta Police Department incorrectly references the function activity as 1320000 (Chief Executive); and

WHEREAS, the correct function activity for the Atlanta Police Department is 3223000 (Patrol); and

WHEREAS, it is the desire of the Department of Public Works and the Atlanta Police Department to correct the Legislation to reflect the correct function activity in Section 2 of the Legislation, "Anticipation and Appropriation," for the Atlanta Police Department as 3223000 (Patrol).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS
as follows:

SECTION 1: That Ordinance Number 15-0-1486 is hereby corrected by deleting the incorrect function activity for the Atlanta Police Department in Section 2 of the Legislation and replacing it with the correct function activity for the Atlanta Police Department, which is 3223000 (Patrol) wherever the incorrect function activity appears in Ordinance Number 15-0-1486.

SECTION 2: That Section 2 of Ordinance 15-0-1486 is hereby deleted in its entirety and replaced with the following, for the purpose of correcting the function activity for the Atlanta Police Department therein:
