A RESOLUTION BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE MAYOR TO ISSUE A TASK ORDER TO ARCADIS/BPA, A JOINT VENTURE, FOR FC-7383A-ARCHITECTURAL, ENGINEERING AND DESIGN SERVICES, ON BEHALF OF THE CITY OF ATLANTA FOR CONSTRUCTION DOCUMENTS AND DESIGN DEVELOPMENT STANDARDS FOR THE CONSTRUCTION OF A PEDESTRIAN BRIDGE FROM THE GOVERNMENTAL CENTER PARKING DECK TO THE MUNICIPAL COURT BUILDING ON BEHALF OF THE EXECUTIVE OFFICES- OFFICE OF ENTERPRISE ASSETS MANAGEMENT, IN AN AMOUNT NOT TO EXCEED THREE HUNDRED FOUR THOUSAND THREE HUNDRED AND SEVENTY-NINE DOLLARS AND NO CENTS (\$304,379.00), ALL WORK TO BE CHARGED TO AND PAID FROM ACCOUNTS LISTED; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) entered into FC-7383A Architectural, Engineering and Design Services (“Agreement”) with Arcadis/Brindley, Pieters & Associates, Inc., a Joint Venture (“Arcadis”) on behalf of the City pursuant to Resolution 15-R-4032 adopted by the Atlanta City Council on September 8, 2015 approved by the Mayor on September 17, 2015; and

WHEREAS, the contract for FC-7383; Architectural, Engineering and Design Services, was executed on November 10, 2015; and

WHEREAS, the City is in need of construction documents and design development standards for the construction of a pedestrian bridge from the Governmental Center Parking Deck to the Municipal Court Building; and

WHEREAS, the preparation of the required construction documents and design development standards may be obtained from Arcadis/ BPA Joint through issuance of a Task Order under the Agreement; and

WHEREAS, the term of the Agreement is for three (3) years with two (2) one (1) year renewal options to be exercised at the City’s soled discretion; and

WHEREAS, the Director of Facilities Management recommends issuing a Task Order for preparation of construction documents and design development standards for the construction of the above-described pedestrian bridge in amount not to exceed Three Hundred Four Thousand Three Hundred and Seventy-Nine Dollars and No Cents (\$304,379.00), and

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his authorized designee, is authorized to issue a Task Order to Arcadis/Brindley, Pieters & Associates, Inc., A Joint Venture for FC-4906A, Architectural, Engineering and Design Services for construction documents and design development standards for the construction of a pedestrian bridge from the Governmental Center Parking Deck to the Municipal Court building in an amount not to exceed Three Hundred Four Thousand Three Hundred and Seventy-Nine Dollars and No Cents (\$304,379.00).

BE IT FURTHER RESOLVED, that all contracted work will be charged to and paid from 3148 (Capital Finance) 040416 (EXE Capital Project) 5413002 (Building Improvement) 314822281 (OEAM Infrastructure Bond) 04112217(Task 101.3) 1512000 (Accounting)

BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to assist the City Attorney in preparation of the appropriate contract documents for execution by the Mayor.

BE IT FINALLY RESOLVED, that this task order shall not become binding upon the City, and the City shall incur no liability or obligation under it until such agreement has been signed by the Mayor attested by the Municipal Clerk, approved by the City Attorney as to form and delivered to Arcadis/BPA, A Joint Venture.
