

AN ORDINANCE BY COUNCILMEMBERS KWANZA HALL AND NATALYN ARCHIBONG AN ORDINANCE AUTHORIZING THE MAYOR, OR HIS DESIGNEE, TO PROHIBIT PARKING ON THE WESTBOUND LANE OF CHAMBERLAIN STREET, SE, FROM BOULEVARD, SE TO JACKSON STREET, SE; TO PROHIBIT PARKING ON EDGEWOOD AVENUE, SE, FROM HILLIARD STREET, NE TO DANIEL STREET, NE, FROM 7:00P.M. TO 7:00A.M.; AND FOR OTHER PURPOSES.(HELD 9/30/15 AT THE REQUEST OF THE AUTHOR AND THE DEPARTMENT OF PUBLIC WORKS.)

WHEREAS, residents and businesses have expressed their concern to their elected representative on parking issues in the Old Fourth Ward Community; and

WHEREAS, the club district creates parking and cruising issues for residents and businesses in the vicinity of Chamberlain Street, SE and Edgewood Avenue, SE.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

SECTION 1: The Mayor, or his designee, is authorized to prohibit parking on the westbound lane of Chamberlain Street, SE from Boulevard, SE to Jackson Street, SE.

SECTION 2: The Mayor, or his designee, is authorized to prohibit parking on Edgewood Avenue, SE, from Hilliard Street, NE to Daniel Street, NE from 7:00A.M. to 7:00P.M.

SECTION 3: The Department of Public Works is hereby authorized to install the appropriate signage.

SECTION 4: All ordinances and parts of ordinances in conflict herewith are hereby waived to the extent of the conflict.
