

WHITE PARK ON BEHALF OF THE CITY OF ATLANTA IN THE AMOUNT OF SEVENTY THOUSAND DOLLARS (\$70,000.00); TO BE CHARGED TO AND PAID FROM ACCOUNTS LISTED HEREIN; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) owns and operates John A. White Park (“Park”) as a facility of recreation for the benefit of its citizens and all those who visit the Park; and

WHEREAS, The First Tee has been a component and programmatic golf initiative at the Park (the “Services”); and

WHEREAS, as part of performing the Services at the Park, The First Tee made certain infrastructure improvements to the Park in the amount of Seventy Thousand Dollars (\$70,000.00); and

WHEREAS, the Commissioner of Parks and Recreation and the Chief Procurement Officer recommend reimbursement to The First Tee in the amount of Seventy Thousand Dollars (\$70,000.00) for infrastructure improvements made to John A. White Park.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That Section 2-1187 of Article X Procurement and Real Estate Code of the City of Atlanta code of Ordinances is waived to the extent of any conflict with this Ordinance.

SECTION 2: That the Chief Financial Officer is authorized to remit payment in the amount of Seventy Thousand Dollars (\$70,000.00) to The First Tee.

SECTION 3: That all contracted work shall be paid to and from: 1001(General Fund) 140201 (PRC Parks Admin) 5212001 (Consultant Prof) 6210000 (Park Administration).

SECTION 4: That all ordinances or parts of ordinances in conflict with this ordinance, are waived to the extent of the conflict only.
