AN ORDINANCE TO AMEND THE FY16 (JOB TRAINING GRANT FUND) BUDGET TO ANTICIPATE AND APPROPRIATE A GRANT IN THE AMOUNT OF ONE HUNDRED FORTY FIVE THOUSAND DOLLARS AND ZERO CENTS (\$145,000.00) AWARDED BY THE GEORGIA DEPARTMENT OF HUMAN SERVICES TO THE ATLANTA WORKFORCE DEVELOPMENT AGENCY FOR THE GEORGIA TEENWORK INTERNSHIP PROGRAM; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Department of Human Services has awarded the Atlanta Workforce Development Agency ("AWDA") a Georgia TeenWork grant in the amount of One Hundred Forty Five Thousand Dollars And Zero Cents (\$145,000.00) to provide employment training services to youth aging out of the foster care system; and,

WHEREAS, the City of Atlanta is the fiscal agent for all grants received by AWDA.
