AN ORDINANCE AUTHORIZING A DONATION IN AN AMOUNT NOT TO EXCEED FIVE HUNDRED DOLLARS AND ZERO CENTS (\$500.00) FROM THE POST 1 AT-LARGE CARRY FORWARD ACCOUNT TO THE RONNIE THAMES FOUNDATION FOR THE PURPOSE OF PURCHASING FIRE AND CARBON MONOXIDE DETECTORS AND FIRE EXTINGUISHERS FOR THE COMMUNITY; AND FOR OTHER PURPOSES.

WHEREAS, the Ronnie Thames Foundation is a non-profit organization committed to teaching fire prevention and helping families whose lives have been devastated in some way by fire; and

WHEREAS, additionally, the Ronnie Thames Foundation has proved its dedication to community involvement by creating a 1st through 3rd grade program, established with local fire departments, to help teach children about burn and fire prevention; and

WHEREAS, the Post 1 At-Large Councilmember recently partnered with the Ronnie Thames Foundation, the Atlanta Fire and Rescue Department and the Atlanta Police Department to launched a Save-A-Life Blitz Campaign; and

WHEREAS, the Campaign focuses on testing and/or installing smoke and carbon monoxide detectors and distributing fire extinguishers and materials on safety tips to the community; and

WHEREAS, it is the desire of the Post 1 At-Large Councilmember to donate Five Hundred Dollars and Zero Cents to help the Ronnie Thames Foundation continue its mission of providing fire and carbon monoxide detectors and fire extinguishers for the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA GEORGIA, to be read as follows:

SECTION 1: That the Chief Financial Officer is authorized to remit payment of Five Hundred Dollars and Zero Cents to the Ronnie Thames Foundation.
