The Department of Aviation (DOA) has completed its review of the Bid Packages as provided by the Department of Procurement (DOP) for the above referenced projects.

The seven (7) qualified proponents for FC-8510 as determined by DOP were ATL Resurgens Joint Partners, LLC. (SSP America), Vida Concessions Inc., Atlanta Airport Concessions, LLC, Statewide Healthcare DBA Brain Child, LLC (Gloria Jean's Coffees), iii Enterprises, Inc., HBF Verge Partners I JV, LLC and Gourmet Services, Inc.

The seven (7) qualified proponents for FC-8511 were ATL Resurgens Joint Partners, LLC. (SSP America), Atlanta Airport Concessions, LLC, CI/HH Better Burger, LLC, MEM Concessions dba five Guys, Velocity Airport Concessions, LLC, HBF Verge Partners I JV, LLC and Gourmet Services, Inc.

The ten (10) qualified proponents for FC-8512 were ATL Resurgens Joint Partners, LLC. (SSP America), Atlanta Airport Concessions, LLC, McDonalds USA, LLC, Mack II Incorporated, CI/HH Better Burger, LLC, MSE Branded Foods of Atlanta, LLC, MEM Concessions dba Five Guys, Velocity Airport Concessions, LLC, HBF Verge Partners I JV, LLC and Gourmet Services, Inc.

The five (5) qualified proponents for FC-8484 were ATL Resurgens Joint Partners, LLC. (SSP America), Atlanta Airport Concessions, LLC, Charles Bush Consulting (CBC), LLC, Delaware North Companies, Travel Hospitality Services, Inc., and Global Concessions, Inc.

HBF Verge Partners I JV, LLC was the top-ranked, most responsible, responsive proponent for both FC-8511 Branded Hamburger Concession – Concourse A and FC-8512 Branded Hamburger



Concession – Concourse B. These two Hamburger locations included in FC-8511 and FC-8512 were subject to award limitations and Proponents were required to submit a Preference Form. The attached preference form for HBF Verge Partners I JV, LLC indicated that Branded Hamburger Concession – Concourse B was their first choice.

FC-8510 Branded Coffee Concession – Concourse A: based on the attached Final Scores received from DOP, DOA hereby recommends award to the top-ranked, responsible, responsive proponent Atlanta Airport Concessions, LLC.

FC-8511 Branded Hamburger Concession – Concourse A: based on the attached Final Scores received from DOP for the FC-8511, DOA hereby recommends award to the second-ranked, responsible, responsive proponent CI/HH Better Burger, LLC.

FC-8512 Branded Hamburger Concession – Concourse B: DOA hereby recommends award to the top-ranked, responsible, responsive proponent HBF Verge Partners I JV, LLC.

FC-8484 Food and Beverage Concessions on Concourse C Midpoint, DOA hereby recommends award to the top-ranked, responsible, responsive proponent Global Concessions, Inc.
