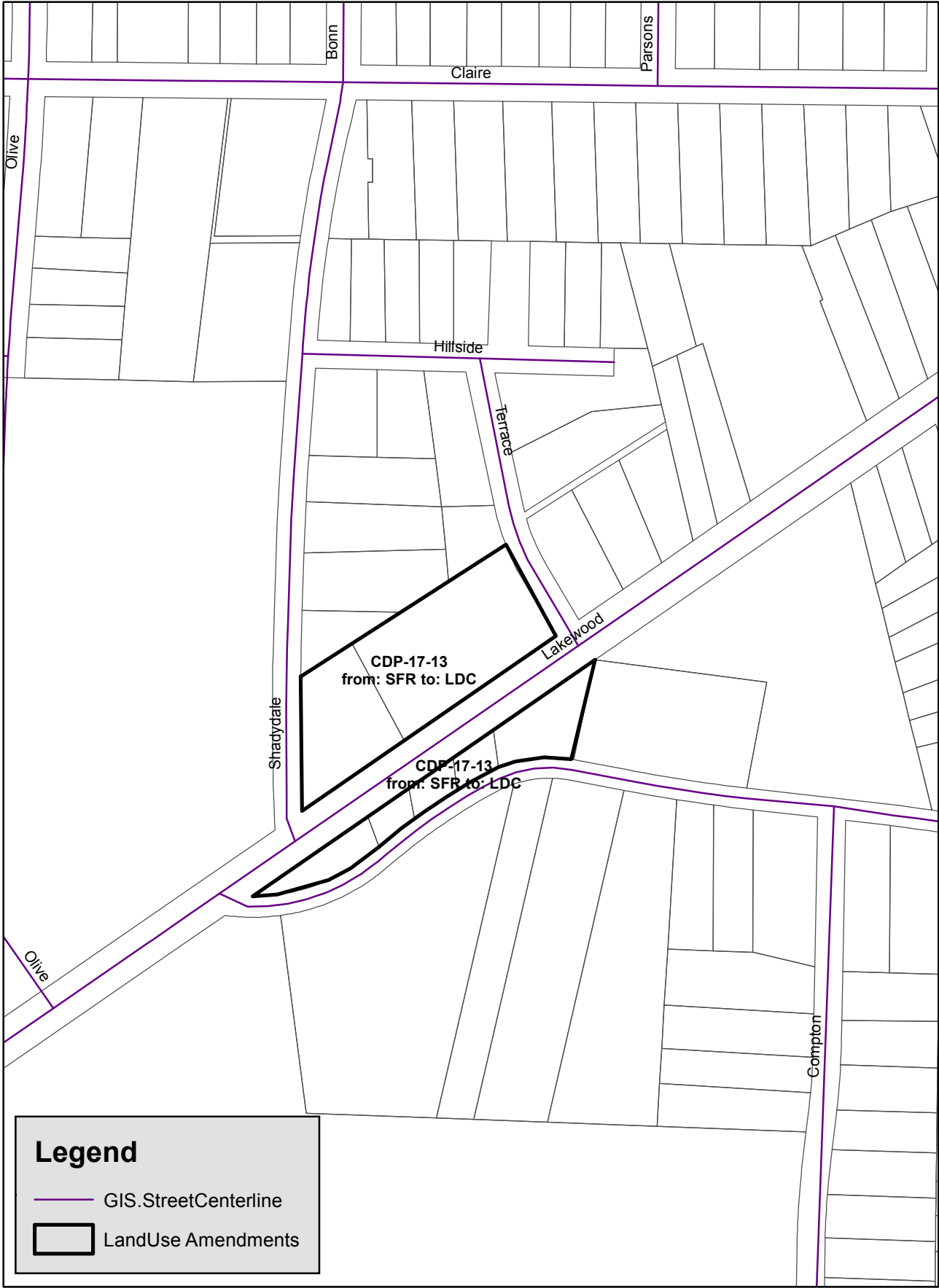

SECTION 1. An ordinance to amend the Land Use element of the 2016 Atlanta Comprehensive Development Plan (CDP) so as to redesignate property located in the Lakewood Heights neighborhood from the Single Family Residential land use designation to the Low Density Commercial land use designation and for other purposes to wit:

All that tract or parcels of land lying and being in Land Lot 58 of the 14<sup>th</sup> District of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A', which is hereby made a part of this ordinance.

SECTION 2. That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
