**SUBJECT: BACE APPOINTMENT NOTIFICATION

As you may know, the Atlanta City Council appointed R. Kirk Rich to the Invest Atlanta Board of Directors in the Real Estate category, via the attached Resolution 14-R-3911. However, Kirk Rich has filed a Declaration of Intention to Accept Campaign Contributions in support of his seeking elected office in the City of Atlanta's upcoming election. Consequently, he has submitted a letter, dated April 17, 2017, notifying Mayor Kasim Reed of his resignation from the Invest Atlanta Board of Directors (also attached).

In turn, I ask that you please notify all council members that the real estate category seat on the Invest Atlanta Board of Directors, to be appointed by the City Council, is currently vacant.

Pursuant to City Code Section 2-1852, the Chair of the Committee on Council **shall provide written notice to all council members that nominations of an individual or individuals or a councilmember or councilmembers shall be submitted to the Chair of the Committee on Council by a specified deadline.** If one or more nominee is received, the Chair of the Committee on Council shall proceed accordingly towards the confirmation process or the waiver of requirements as outlined in Section 2-1852.
