A RESOLUTION TO AUTHORIZE THE MAYOR, OR HER DESIGNEE, TO ISSUE A TASK ORDER TO XXXX, INC. FOR FC-XXXX, XXXX FOR SIDEWALK IMPROVEMENTS ON ANDERSON AVENUE, N.W. IN COUNCIL DISTRICT 3 ON BEHALF OF THE DEPARTMENT OF PUBLIC WORKS IN AN AMOUNT NOT TO EXCEED SEVEN HUNDRED THOUSAND DOLLARS AND NO CENTS (\$700,000.00); ALL CONTRACTED WORK TO BE CHARGED TO AND PAID FROM THE ACCOUNT NUMBERS LISTED HEREIN; AND FOR OTHER PURPOSES.

WHEREAS, the City of Atlanta (“City”) did solicit bids for Contract Number FC-XXXX, XXXX (“Agreement”); and

WHEREAS, the base term of the Agreement is for a period of two (2) years with three (3) one (1) year renewal options to be exercised at the sole discretion of the City; and

WHEREAS, the Commissioner of the Department of Public Works recommends the issuance of a Task Order to XXXX, for FC-XXXX, Annual Contract for the Maintenance and Repair of Sidewalks, Curbs, Driveway Aprons and Associated Infrastructure for sidewalk improvements on Anderson Avenue, NW in Council District 3 in an amount not to exceed Seven Hundred Thousand Dollars and Bo Cents (\$700,000.00).

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, or his designee, is authorized to issue a Task Order to XXXX, for FC-XXXX, with XXXX, Inc. for sidewalk improvements on Anderson Avenue, NW in Council District 3 in an amount not to exceed Seven Hundred Thousand Dollars and Bo Cents (\$700,000.00).



BE IT FURTHER RESOLVED, that the Chief Procurement Officer is directed to assist the City Attorney in the preparation of the appropriate agreement for execution by the Mayor, or his designee.

BE IT FINALLY RESOLVED, that the Task Order will not become binding upon the City, and the City will incur no obligation or liability under it until the it has been approved by the City Attorney as to form, executed by the Mayor, attested to by the Municipal Clerk and delivered to XXXX.
