AN ORDINANCE AMENDING THE 2018 (INTERGOVERNMENTAL GRANT FUND) BUDGET, DEPARTMENT OF POLICE, BY ADDING TO ANTICIPATIONS AND APPROPRIATIONS IN THE AMOUNT OF FIVE HUNDRED FORTY-SIX THOUSAND, SIXTY-TWO DOLLARS (\$546,062) FOR THE 2018 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (“JAG”) AWARD FROM UNITED STATES DEPARTMENT OF JUSTICE, AND FOR OTHER PURPOSES.

WHEREAS, the United States Department of Justice (“DOJ”) has, through the 2018 Edward Byrne Memorial Justice Assistance Grant Program (“2018 JAG”), awarded the Atlanta Police Department (“Department”) and Fulton County Government a joint grant award totaling five hundred forty-six thousand, sixty-two dollars (\$546,062); and

WHEREAS, the Department will receive the entire joint award and then pay to Fulton County their share of the joint award as agreed to in the Memorandum of Understanding approved by resolution 18-R-3967.

WHEREAS, the pay-out to Fulton County for their share of the joint award is one hundred thirty-six thousand, five hundred sixteen dollars (\$136,516) and the Atlanta Police Department will retain four-hundred nine thousand, five hundred forty-six dollars (\$409,546) to fund police initiatives; and for other purposes.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the 2018 (Intergovernmental Grant Fund) Budget, Department of Police is hereby amended as follows:
