**A RESOLUTION REQUESTING THE ADMINISTRATION
APPOINT A SPECIAL ADVOCATE FOR POLICE OFFICERS,
FIRE FIGHTERS, AND OTHER EMPLOYEES WHO HAVE
SUSTAINED CATASTROPHIC INJURIES THAT OCCURRED
DURING THE LINE OF DUTY; TO ASSIGN A COMMITTEE OF
PURVIEW AND TIME FRAME FOR SUCH DUAL REPORTING;
AND FOR OTHER PURPOSES.**

WHEREAS, the care of the City of Atlanta Police Officers, Firefighters, and all other employees is of significant importance to the City of Atlanta and its elected officials; and

WHEREAS, the Atlanta City Council has received multiple reports at Council Committees and Full Council Meetings of employees who were injured in the line of duty and have experienced hardships when attempting to receive benefits from the City's administrator of benefits and/or its representative; and

WHEREAS, the Atlanta City Council desires to be kept informed of these incidences in order to ensure that proper care is being given to Police Officers, Firefighters, and other City of Atlanta employees.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, that the Atlanta City Council requests the Mayor's Office appoint a Special Advocate to report to both the Mayor and to the City Council on the issues and outcomes related to the care of Police Officers, Firefighters, and other employees that have sustained catastrophic injuries in the line of duty; and

BE IT FINALLY RESOLVED, that the Finance/Executive Committee shall receive a report and presentation from the appointed advocate within 90 days of the adoption of this Resolution.
