THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA HEREBY ORDAINS:

SECTION 1 An ordinance to amend the Land Use element of the 2011 Atlanta Comprehensive Development Plan (CDP) so as to redesignate a portion of property located at 668 Atlanta Student Movement Blvd SW from the Medium Density Residential land use designation to the Mixed Use Low Density land use designation and for other purposes and for other purposes to wit:

All that tract or parcels of land lying and being in Land Lot 109 of the 14th district of Fulton County, Georgia. Said property is more specifically shown on the attached map, Exhibit 'A' and the legal description in Exhibit 'B' which is hereby made a part of this ordinance.

SECTION 2 That all ordinances or parts of ordinances which are in conflict with this ordinance are hereby repealed.
