

A RESOLUTION BY COUNCILMEMBER MICHAEL JULIAN BOND AUTHORIZING THE MAYOR, ON BEHALF OF THE CITY TO ACCEPT DONATIONS OF CLOTHING AND OTHER ITEMS AS PART OF A TEXTILE RECYCLING PROGRAM SPONSORED BY THE POST 1 AT-LARGE COUNCILMEMBER; AND FOR OTHER PURPOSES.

WHEREAS, the Post 1 At-Large Councilmember has established a Textile Recycling Program to collect unwanted clothing, shoes, purses, and other items; and

WHEREAS, bins will be placed at various City of Atlanta Recreation Center to accept these textile items beginning the week of July 5, 2016; and

WHEREAS, the Post 1 At-Large Councilmember will partner with the Charity Recycling Service and The Center for Hard to Recycle Materials to facilitate this event; and

WHEREAS, the Charity Recycling Services is an established for-profit textile recycling company which provides sustainable fundraising to hundreds of local & national corporations, non-profits, educational institutions, and community organizations; and

WHEREAS, the Center for Hard to Recycle Material ("CHaRM") is a permanent facility, located in Southeast Atlanta, that encourages reuse, while diverting thousands of pounds of household hazardous waste, bulky trash and other hard to recycle items from households, landfills, and the water supply; and

WHEREAS, quality items will be repurposed and provided to organizations both domestic and internationally; and

WHEREAS, unusable clothing or textiles will repurposed into paper or low grade textile items;
And

WHEREAS, the Textile Recycling Program seeks to reinforce practices of recycling, repurposes, and sustainability beyond paper, plastics, and other commonly recycled items; and

WHEREAS, the City is appreciative of the generosity of the public to provide these donated items.


NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY RESOLVES, that the Mayor, on behalf of the City of Atlanta, is hereby authorized to

accept a donation of unwanted clothing, shoes, purses and other items, as part of the Post 1 At-Large Textile Recycling Program to be conducted at various City recreation center beginning the week of July 5, 2016.
