**AN ORDINANCE BY COUNCILMEMBER NATALYN ARCHIBONG AUTHORIZING THE INSTALLATION OF ALL-WAY STOP SIGNS AT THE INTERSECTIONS OF GIBSON STREET, S.E. AND MAULDIN STREET, S.E.; GIBSON STREET, S.E. AND CUMMINGS STREET, S.E.; HOLTZCLAW STREET, S.E. AND MAULDIN STREET, S.E.; AND CHESTER STREET, S.E. AND FULTON TERRACE, S.E.; AND FOR OTHER PURPOSES.**

WHEREAS, the residents and surrounding property owners in the Reynoldstown neighborhood near the intersections of Gibson Street, S.E. and Mauldin Street, S.E., Gibson Street, S.E. and Cummings Street, S.E., Holtzclaw Street, S.E. and Mauldin Street, S.E., and Chester Street, S.E. and Fulton Terrace, S.E. have submitted requests to the City of Atlanta (“City”) for all-way stop signs to be installed at these intersections, expressing their concerns about the safety of the intersections; and

WHEREAS, the City has performed traffic studies and field investigations at the aforesaid intersections; and

WHEREAS, the analyses and field investigations have revealed that poor visibility and high traffic volume exists due to the topography of the neighborhood and adjacent buildings located near these intersections; and

WHEREAS, the City recommends the installation of all-way stop signs at the intersections of Gibson Street, S.E. and Mauldin Street, S.E., Gibson Street, S.E. and Cummings Street, S.E., Holtzclaw Street, S.E. and Mauldin Street, S.E., and Chester Street, S.E. and Fulton Terrace, S.E.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS, as follows:

SECTION 1: That the intersections of Gibson Street, S.E. and Mauldin Street, S.E., Gibson Street, S.E. and Cummings Street, S.E., Holtzclaw Street, S.E. and Mauldin Street, S.E., and Chester Street, S.E. and Fulton Terrace, S.E. be made all-way stops.

SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby waived for purposes of this Ordinance only, and only to the extent of the conflict.
