A SUBSTITUTE ORDINANCE BY FINANCE/EXECUTIVE COMMITTEE AUTHORIZING THE CHIEF FINANCIAL OFFICER TO AMEND THE FY2015 BUILDING RENEWAL AND EXTENSION FUND (5602) BUDGET IN THE AMOUNT OF THREE MILLION SEVEN HUNDRED THIRTY NINE THOUSAND THREE HUNDRED EIGHTY SEVEN DOLLARS AND ZERO CENTS (\$3,739,387.00) TO TRANSFER FUNDS FROM THE BUILDING RENEWAL AND EXTENSION FUND RESERVES FOR APPROPRIATIONS AND ADD FUNDS TO APPROPRIATIONS FOR VARIOUS PROJECTS; AND FOR OTHER PURPOSES.

WHEREAS, the Office of Buildings Renewal and Extension Fund was established by Ordinance 12-O-0991;

WHEREAS, the City of Atlanta’s Department of Planning and Community Development (“Department”) has identified various projects in the Office of Buildings; and

WHEREAS, the Office of Buildings various projects will include the office restacking, as well as, technology, permitting services, and customer service related initiatives; and

WHEREAS, these funds should be transferred from the Buildings Renewal and Extension Fund Reserves for Appropriations to facilitate the use of the funds for the Office of Buildings various projects.

THE CITY COUNCIL OF THE CITY OF ATLANTA, GEORGIA, HEREBY ORDAINS as follows:

Section 1: That the Chief Financial Officer is authorized to amend the FY2015 Building Permits Renewal and Extension Fund (5602) Budget as follows:
