

WHEREAS, Council District 9 has a large number of blighted properties; and

WHEREAS, many of these properties have been thru the In Rem process and have been legally found eligible for demolition; and

WHEREAS, the City of Atlanta's Demolition Fund for FY 2015 is \$2,095,000.00 and those funds will not meet the needs of all properties in the City of Atlanta that have been approved for Demolition; and

WHEREAS, the Councilmember representing Council District 9 wishes to contribute \$\_\_\_\_\_ to the Demolition Fund for demolition of certain properties in District 9 as determined by the Councilmember in conjunction with the Code Enforcement Division staff ; and

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA, as follows:

SECTION 1: That the Chief Financial officer is authorized to remit payment Code Enforcement Division of the Atlanta Police Department in the amount of \$\_\_\_\_\_ to be used to for demolition of certain properties within Atlanta City Council, District 9.
