2. That the "Capital City Atlanta Day" shall be an annual event held on the second Monday in January



each year, to coincide with the first day of the legislative session.

3. That the Mayor and the City Council host this annual event to promote the City's legislative priorities, bring awareness to the City's legislative progression and foster positive relationships between the City and the General Assembly of the State of Georgia.
