WHEREAS, Communication #14-C-5048 by Mayor Kasim Reed appointing Mr. Randy Hazelton to the Atlanta Development Authority (dba Invest Atlanta) Board of Directors (attached) was confirmed by Council on July 21, 2014; and

WHEREAS, Communication #14-C-5048 stated that Mr. Hazelton was being appointed for a term of three (3) years; and

WHEREAS, the correct term of office of this position on the Atlanta Development Authority (dba Invest Atlanta) Board of Directors is four (4) years; and

WHEREAS, Mayor Reed has submitted, to the Municipal Clerk, a revised communication which reflects the appropriate four (4) year term.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ATLANTA, GEORGIA that the appointment of Mr. Randy Hazelton to the Atlanta Development Authority (dba Invest Atlanta) Board of Directors is hereby corrected to reflect a term of office of four (4) years.

BE IT FURTHER RESOLVED that the Atlanta City Council's confirmation of the Mayor's appointment of Mr. Hazleton to serve on the Atlanta Development Authority (dba Invest Atlanta) Board of Directors now for a term of four (4) years remains effective to begin on July 21, 2014.
